## HOURS

The curriculum at the **Staunton School of Cosmetology Incorporated** is for a 1500 hour course. Full-time students attend 34 hours per week. Hours are from 8:30 AM – 4:30 PM, Tuesday – Friday and 8:30 AM – 1:30 PM on Saturday. Part-time students attend 25 hours per week. Morning part-time students attend from 8:30 AM – 1:30 PM Tuesday - Saturday. Afternoon part-time students attend from 11:30 AM – 4:30 PM Tuesday – Friday and from 8:30 AM – 1:30 PM on Saturday.

## COST

The **STAUNTON SCHOOL OF COSMETOLOGY INCORPORATED** is nationally accredited by the **National Accrediting Commission of Career Arts and Sciences**. Financial aid is offered through the following programs:

**PELL Grant:** Pell Grants are funds that do not have to be repaid. They are awarded based on financial need, and applications are completed at the school. A copy of the anticipated financial aid is provided prior to enrollment.

**SEOG Grant:** The Supplemental Educational Opportunity Grant is available to students who demonstrate exceptional financial need and is intended to

supplement the Pell Grant. The school advises students as to the availability of these funds. Like the Pell Grant, SEOG funds do not have to be repaid.

**Direct Loans:** Direct Loans are available to students who may or may not otherwise qualify for a grant. The school completes all applications and forwards them to lenders.

**Monthly Payments:** The school offers a monthly payment plan for those desiring to make payments for their education.

## CURRICULUM

The curriculum of the **Staunton School of Cosmetology Incorporated** provides a complete course of study in Cosmetology. Theory instruction includes audio-visual aids, lectures, platform demonstrations, and textbook assignments. Hair color technicians, hair cutting artists, and product representatives visit the school from time to time and give special classes for the students' training program. In all classes, the principles are tested and perfected by the student in practical classroom activities. Practical training includes teacher supervised performances on clinic patrons and manikins.

## DIPLOMA AND AWARDS

After the completion of the 1500 Hour program and the Virginia Cosmetology Board Regulations, the graduate will receive a diploma. Special recognition certificates for extra abilities and accomplishments in Permanent Waving, Haircoloring, Chemical Relaxing, Quick Service Techniques and Attendance are given.
