Median Student Debt

Many students use financial aid to help pay for school. Part of that financial aid may be in the form of student loans, with a remaining balance that needs to be paid back after leaving school. We calculate the median debt of students graduating from the program. "Median debt" means that half of students graduate with less outstanding in student loans than the number provided here, and half graduate with more.

For students graduating in the 2021 year (from January 1, 2021 – December 31, 2021), the median student debt was \$9,402.00

Licensure Rate

Getting a state license to practice cosmetology where you want to work is a requirement for finding employment as a hairstylist or cosmetologist. Staunton School of Cosmetology surveys their graduates to identify the percentage of graduates who became licensed by using the reporting methodology required by our accrediting agency, the National Accrediting Commission of Career Arts & Sciences.

SSOC's licensure rate, as measured under the NACCAS reporting requirements was **92.86%** for graduates who sat for the exam in 2021.

Placement Rates

SSOC's placement rate is a measure of the number of graduates who find employment. To

measure placement we follow the reporting methodology required by our accrediting agency, NACCAS. Under this method 100.00% students who graduated in 2021 and were eligible for employment. **85.71%** of these students found employment.
